
PURCHASES FROM SMES


Communication with regions






THE PROGRAM TO STIMULATE SMES CREDITING («THE 6.5 PER CENT PROGRAM»)

On March 18, 2016 the Board of Directors of the Bank of Russia decided to increase the limit on Bank of Russia loans granted to credit institutions, secured by guarantees of the RSMB Corporation, and on Bank of Russia loans granted to the JSC «SME Bank» from 50 to 75 billion rubles (from 767 mln USD to 1,2 bln USD)
